The Texas Ethics Commission is exercising its option under Section 2 (Contract Term and Renewal Options) to extend contract # TEC-FY2022-001 for a two-year term ending 8/31/2025, with the following amendment:

(1) Replace the **7.1 Pricing** language with this language:

### **7.1 Pricing**

Pricing for the TEC Contracting Entity for maintenance services based on the maintenance scope described in Section 5.1 is \$350,000 per 2024 and 2025 fiscal contract year. The payment schedule is as follows:

TEC has the option to purchase additional hours for changes under Section 5.4 *Source Code Changes and Modifications* from the Vendor at a blended hourly rate of \$150/hour on an as needed basis.
